The Association of Black Women Lawyers of New Jersey, Inc. (ABWL-NJ), the oldest women's Bar Association in the State of New Jersey, announces the opening of its <u>2021</u> scholarship application process. ABWL-NJ has awarded over \$100,000 in scholarships to female law students of African descent.

Applicants must meet the following criteria:

- (1) Be a female of African American descent;
- (2) Be enrolled at an accredited law school in New Jersey, or be a New Jersey permanent resident enrolled at an accredited law school outside New Jersey; and
- (3) Be a 1L, 2L OR 3L/4L part-time (May 2021 graduates not eligible).

The following factors will be considered:

- (1) Community service/civil involvement;
- (2) Academic achievement; and
- (3) Financial need.

*The winners will be announced by April 9, 2021,* may be posted on ABWL-NJ's website, and acknowledged in the Souvenir Journal for our Scholarship Jazz Brunch on May 1, 2021. This year's theme is: Changemakers - Paving the Way Forward (Past, Present, Future).
