



OUR HISTORY

ASSOCIATION OF BLACK WOMEN LAWYERS OF NEW JERSEY

The Founders of the Association of Black Women Lawyers of New Jersey (ABWL-NJ) established an organization to meet the needs of Black women and students interested in the practice of law.

Their dream became a reality in 1975 when they formed ABWL-NJ, a non-partisan, non-profit organization that promotes the participation of African-American women in the field of law. The oldest women's bar association in New Jersey, ABWL-NJ has spent four decades engaged in strategies designed to gain the legal, educational, economic and social empowerment necessary to enhance the quality of life for African-American women, their families and the New Jersey community-at-large.

ABWL-NJ's commitment to providing outstanding service to women and to the wider community is demonstrated by an untiring commitment to improving the quality of life for all. ABWL-NJ is actively involved in facilitating and disseminating information and discussion on a wide range of topics including public education, domestic violence, mortgage foreclosure, the juvenile justice system and the challenges of mass incarceration of people of color. ABWL-NJ has cooperated with other state, county and specialty bar associations to address these important issues.

The Social Justice Committee of ABWL-NJ has enhanced its grass-roots outreach, providing workshop speakers to the New Jersey Black Issues Convention, New Jersey Legislative Black Caucus, and The New Jersey NAACP State Conference as well as to the NJSBA. In accordance with ABWL's stated Mission, the Social Justice Committee strategically takes positions in opposition to or in support of pending legislation which impacts the Black community. The Committee advocates by letter writing to elected officials, issuing Press Releases, or signing on to Press Releases with our social justice coalition partners such as NJISJ, NJ-BIC, Salvation & Social Justice, the NJ NAACP, Fair Share Housing, Rutgers Inclusion Project, New Jersey Policy Prospective and The Black Multi Faith Alliance all of the United Black Agenda Group. The Joint ABWL & GSBA Judicial and Prosecutorial Appointments Committee (JPAC) which was born out of the social justice agenda continues to work diligently to bring diversity to the Superior Court, Administrative Law, and Workers Compensation Bench in New Jersey as well as to New Jersey's Board and Commissions. To date, more than 15 Black women have been appointed to the bench due to the work of the joint commission since the beginning of Governor Phil Murphy's administration.

ABWL-NJ is also known for its Law Day programs in schools and other community based venues; its Pink and Black Affair to promote awareness of breast cancer prevention and provide financial assistance for medical care for women of color; and its annual Scholarship Fundraiser (frequently hosted as a Jazz Brunch), the traditional forum through which it awards book grants and scholarships to Black women law students and also recognizes the professional achievements of those who have made significant contributions to the community. ABWL-NJ recently created the Law Student Emergency Needs Fund to address law student needs outside of grants and scholarships and has grown a robust law student mentoring program, as well as mentoring programs for girls in middle schools throughout the state. In addition, ABWL-NJ continues to advocate for increased access of persons of color and women into the legal profession, support efforts to preserve law school admission policies that promote their enrollment, encourage employment practices that promote diversity, and champion equal rights under the law through active participation on NJ Supreme Court Committees, in specialty bar associations and in the New Jersey State Bar Association. In further keeping with its service mission, ABWL-NJ created the Honorable Anne E. Thompson American Inn of Court in March 2009 (renamed The Honorable Marie White Bell, JSC (ret) in 2019), which provides continuing legal education and fosters fellowship among the bar and bench. In sum, ABWL-NJ remains committed to:

- Providing forums to disseminate legal information on matters of interest to attorneys of color; ;
- Fostering communication, cooperation and understanding within the legal profession;
- Assisting in service to charitable organizations and the Bar;
- Encouraging and assisting students in the pursuit of a career in law;
- Encouraging its members to maintain high standards of conduct and professionalism.

She has also taught courses in Legal Writing, Administrative Law, and Trial Advocacy and has directed student programs focusing on externships, mock trial and moot court. Judge Brewer is also a frequent international lecturer and trainer, having conducted legal writing, trial advocacy and judicial judgment drafting trainings in Saudi Arabia, India and throughout the African continent in conjunction with the African Union. Her scholarly focus spans several areas of her professional expertise including, examining the intersectionality of racial justice, ethics and religion, gender equity, global women's leadership, and criminal justice reform for women and girls.

Judge Brewer was recently appointed by the New Jersey Governor as the first African-American to Chair the New Jersey State Commission of

Investigation, an independent investigatory agency empowered to expose organized crime, government fraud and corruption. Throughout her career, Judge Brewer has served in high profile leadership roles in government including as an Administrative Law Judge, Assistant U.S. Attorney for the District of New Jersey, Deputy Chief Counsel to the NJ Governor, Chief Counsel to the Speaker of the NJ General Assembly, NJ Deputy Assistant Secretary of State (overseeing the state's election system), and Regulatory Officer (agency counsel) at the NJ Civil Service Commission. In private practice, she has served as a litigation associate at several large law firms in Massachusetts and New Jersey. Judge Brewer started her career as a law clerk to the Honorable Frederick L. Brown in the Massachusetts Appeals Court. During law school, Judge Brewer had the unique opportunity to serve as an intern at the White House for the Office of Legal Counsel. Prior to law school, she also served as the Special Assistant to U.S. Senator Bill Bradley.

Judge Brewer is admitted to practice in Massachusetts, New Jersey, the District of Columbia, the Supreme Court of the United States and various federal courts. As an active leader in the profession, Judge Williams currently serves as Secretary of the Section of Litigation of the American Bar Association and as a Fellow of the American Bar Foundation. Previously she served as the ABA Deputy Representative to the United Nations, as an Associate Editor to the Litigation News magazine, member of the Section of Litigation Council and as Section of Litigation Managing Director.

In addition to her legal career, Judge Brewer is a pastor and an advocate for the global advancement of women and girls as Founder & CEO of the Esther Project & the Esther Institute for the Advancement of Women and Girls. Judge Brewer has been recognized for her global work with the Esther Project by a United States Senator, the NJ Legislature, Delta Sigma Theta Sorority, Inc. ASSOCIATION OF BLACK WOMEN LAWYERS OF NJ (ABWL-NJ)

In the 1997-1998 program term ABWL-NJ named its scholarships after two trailblazers: M. Bernadine Johnson Marshall, Esquire and Martha Belle Williams, Esquire. Over the past four decades, ABWL-NJ Scholarship Awards to law students have now exceeded \$150,000. We thank our members, sponsors and supporters for making this possible.

M. BERNADINE JOHNSON MARSHALL SCHOLARSHIP AWARD

Marie Bernadine Johnson Marshall was born in Trenton, New Jersey. Mrs. Marshall attended the Newark Public School System having graduated from West Side High School. She then went to Howard University in Washington D.C., graduating in 1944 with a degree in sociology. At a time when few women attended post-graduate schools, Mrs. Marshall did so and in 1947 graduated from Rutgers Law School. In 1949, Mrs. Marshall began a journey of "firsts," when she and Martha Belle became the first African-American women admitted to the New Jersey Bar.

Mrs. Marshall began her legal career engaging in the general practice of law with her father, the late Jacob B. Johnson, Sr., a former Assistant Prosecutor in Essex County. She focused on matrimonial, immigration, landlord-tenant, estate and general trial law. In May 1955, Mrs. Marshall was appointed Associate Counsel to a United States Senate Judiciary Sub-committee investigating juvenile delinquency. At that time, she was the youngest woman lawyer and only African-American woman lawyer practicing on Capitol Hill. In 1958, she rejoined the practice with her father until 1960. She continued to practice law on her own until her retirement in 1988.

Mrs. Marshall's commitment to the legal and African-American community is evidenced by her involvement in a number of professional and community organizations including, the Urban League of Essex County, the YM-YWCA of Newark, the North Jersey unit of the National Association of Negro Business and Professional Women's Clubs, Inc. and Zonta International, a business women's club. She was also a member of the Essex County Mental Health Association and Planned Parenthood of Essex County. In addition, Mrs. Marshall served on various boards and commissions. She was appointed the first female member of Newark's Alcoholic Beverage Control Board in 1961 and later served as the Board's chairperson. She also served on the boards of the Blue Cross and Blue Shield and the Girls Center of Essex County. In addition, she was a former counsel to the New Jersey State Federation of Negro Women's Clubs, Inc. The recipient of numerous awards, Mrs. Marshall was honored with a State Senate Resolution in 1995 in recognition of these and other trailblazing efforts in law and community service. She was a shining light who paved the way for African-Americans in the field of law. This light was dimmed in September 1997, but her legacy lives on.

MARTHA BELLE WILLIAMS SCHOLARSHIP AWARD

Martha Belle Williams was born January 9, 1924, in Montclair, New Jersey and graduated from local elementary, junior and high schools in that city. She attended Essex County Junior College in Newark and transferred to Upsala College, from which she graduated in 1945 with a Bachelor of Arts degree in history, political science and economics. She received her L.L.B. Degree from Rutgers University School of Law in 1948. In 1949, M. Bernadine Johnson Marshall and Martha Belle Williams changed African-American and New Jersey history by becoming the first African-American women admitted to the New Jersey Bar.

Mrs. Williams started her legal career as a law clerk in the office of Sidney G. Grover of Newark. She later became an associate in the law firm practicing civil and criminal law. Thereafter, she was briefly associated with both J. Mercer Burrell of Newark and Louis E. Saunders of Jersey City in the practice of general law. In 1968, Mrs. Williams was named senior attorney for the Montclair Office of the Essex County Legal Services. In this position, she gained local notoriety for her uncanny commitment to economically disadvantaged people whom she counseled and advised.

Mrs. Williams was a member of the Essex County and New Jersey Bar Associations, the American Judicature Society and the Montclair Chapter of the National Council of Negro Women. She also served as President of the Montclair Young Women's Christian Association (YWCA) and at the time of her appointment, was the youngest woman in the United States to attain that position.

Mrs. Williams was highly respected for her ability to bring a ray of sunshine and hope to everyone she encountered. That ray was extinguished prematurely in June 1969, when she died at the age of 45. Mrs. Williams' legacy continues through the many attorneys she touched and the legal scholars who recognize her contributions to the profession.

M. BERNADINE JOHNSON MARSHALL SCHOLARSHIP AWARD

SHELLEAH JACKSON



Shelleah Jackson is a native of the Greater Philadelphia Area. She attended the University of Pittsburgh where she obtained her Bachelor of Arts in Health Services on a pre-law track. Upon graduation, Shelleah was accepted into Teach for America, where she served in Charlotte, NC as a ninth grade Honors English teacher and the head coach of the Speech and Debate team.

She obtained her Master of Science in Education with a focus in Secondary Education and after some rewarding years as a teacher, Shelleah transitioned into the education nonprofit sphere where she worked as a Program Manager of a black-owned leadership organization. There, she created, implemented, and trained staff on interactive curriculums to build leadership, public speaking, and professionalism skills in 350 high-achieving black high school students. Shelleah worked as the Tutor Manager of a Raleigh-based nonprofit that provides free or low-cost research-based, highly effective math and literacy tutoring programs for teachers and school districts. In this role, Shelleah built and maintained strategic partnerships with companies, universities, and community organizations to recruit and manage 900 tutors to tutor 600 students weekly.

Shelleah is proud to be a second-year student at Rutgers Law School, Camden. This year, she is a Staff Editor on the Rutgers University Law Review, the Diversity and Inclusion Representative for the Student Bar Association (SBA), a Legal Writing Fellow/Teaching Assistant, and a member of the Intramural Mock Trial Team. Additionally, last semester, she served as the Judicial Extern to The Honorable Karen Williams in the United States District Court for the District of New Jersey.

MARTHA BELLE WILLIAMS SCHOLARSHIP AWARDS

ZANIYA LEWIS



Zaniya Lewis is the Founder/CEO and Executive Director of YesSheCanCampaign, a 501(c)(3) non-profit organization that inspires young people to be extraordinary and change the world. YesSheCanCampaign has reached 3,000+ students and volunteered 20,000+ hours. The organization has won national and international recognition and helped students win over \$700,000 in educational funding.

In 2019, Zaniya became a victim of scholarship displacement and she has used her story to spread awareness about scholarship award displacement through her nonprofit YesSheCanCampaign. YesSheCanCamaign launched a national campaign to dismantle scholarship award displacement, as well as DISSCHOLARED, an award-winning program that spreads awareness about scholarship award displacement. Inspired by her story, in 2021 New Jersey enacted legislation to restrict scholarship award displacement, becoming the second state in the nation to outlaw this brutal practice. Her advocacy inspired The Helping Students Plan for College Act 2021, the first-ever federal bill to address scholarship award displacement nationwide.

In May 2020, Zaniya received her B.A in Political Science from The George Washington University. Zaniya is currently a second-year law student at Rutgers Law School. Zaniya has received many accolades for her work, including the Diana Award and Taco Bell Foundation Live Mas Scholarship. Zaniya's mission in life is to inspire others to keep climbing and to use their passions to make a difference in the world.






